### REMITAND MEMBERSHIP OF LOCAL DEVELOPMENT GROUP AND WORK PLAN

#### 1.0 Purpose

- 1.1 The purpose of this report is to advise the Group of its remit and membership and to propose a work plan

#### 2.0 Remit and Membership

- 2.1 Key to the success of the School Estate Development Programme will be effective communication with stakeholders and the wider community. At its meeting of 21 August, 2008 the Education and Children's Services Committee considered a report by the Executive Director (Education) providing an update on work of the School Estate Development Programme; outlining the overall work programme being followed; proposing governance, communication and reporting arrangements, and suggesting the brand identity "Building Fife's Future". The Committee approved the recommendations contained in the report (minute paragraph 163 of 2008.E.Chs.84 refers), including the formation of a local development group for each of the schools in the School Estate Development Programme and a remit for such local development groups.

- Be a forum for discussing the benefit outcomes and design development of specific school estate projects
- Provide good communication links amongst Fife Council Services, the design team, construction contractor, school and community representatives, parents pupils and other users of the facilities
- Cascade information to stakeholders represented by members of the Group
- Participate in surveys and workshops and other feed back sessions on specific school estate related projects
- Receive reports on the progress of specific school estate related projects
